Since the pandemic began in March 2020 Curtis Creek School District regularly provided information to stakeholders through letters, auto dialers, and emails. Information was provided through surveys and the opportunity to contact the school site and district office for input on needs. Stakeholder groups included students, parents, guardians, school and district administrators, teachers, support staff, and students. Zoom meetings were also held. All stakeholder input was taken into account in the development and alignment of the Learning Continuity and Attendance Plan and the Extended Learning Opportunities Plan. Staff has had ongoing opportunities to provide input during staff meetings and through email. At our next board meeting on October 21, 2021, Curtis Creek School District will include the approval of the Esser 111 plan and the opportunity for public comment. In addition Curtis Creek School District also sought input from individuals or agencies representing the interests of Tribal Youth, Homeless and Foster Youth, youth who are low-income, youth who are incarcerated, students with disabilities, students of color, and students who are English Learners. Input was also received from community organizations and partners such as the Yes Partnership and ATCAA, the Amador-Tuolumne Community Action Agency. This outreach occurred during the time period of September 8-September 17, 2021. A survey for written responses was created and distributed during a meeting of the Student Attendance Review Board Members, which represent a number of agencies working with youth in the community, and with follow up emails as well as direct outreach to other community agencies and representatives through email and phone calls.” Civil Rights Organizations and Migratory Students are not present or served by the LEA. EL families gave input through participation in surveys, etc.

Feedback from the community engagement strategies described above was incorporated into the development of the specific strategies for addressing the loss of instructional time and providing supplemental instruction and support for identified students. The feedback included a commitment to in person learning, small group support and intervention, maintaining a counseling program, and high quality summer school opportunities. There continues to be a need for curriculum that is research based for intervention programs. The services and opportunities described in the ESSER iii plan incorporates all feedback and continues to build on the ELO and LCAP goals of supporting safe and continuous in person learning while addressing the academic, social, emotional, and mental health needs of all students.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
